



PRIVACY POLICY

Credit Financier Invest (DIFC) Limited

Regulated by the Dubai Financial Services Authority

This Privacy Policy (the "Policy") covers Credit Financier Invest (DIFC) Limited ("CFI DIFC" or the "Company") and its Website: www.cfidubai.com in addition to its online services (together the "Site" or "Website") regarding types of information that CFI DIFC may collect from the Site and the treatment of these personal information. This Policy will also provide you with instructions on what to do if you do not wish to share personal information with CFI DIFC when visiting its Site. For purposes of this Privacy Policy, personal information is information about you that is personally identifiable including but not limited to: name, age, personal identification information, address, e-mail address or phone number.

This Policy only applies to the Site and people that CFI DIFC employs or manages regarding the administration of the said Site. The CFI DIFC Website is only intended for persons of legal trading age.

If someone under the legal investing age provides the Company with personal information by obtaining access in violation to the Site access restrictions and its terms of use which restricts such, CFI DIFC ask that his/her parent(s) or guardian(s) contact the Customer Service Department by e-mail at: info@cfidubai.com. Upon receiving this request, CFI DIFC will promptly remove such information from the Company's records.

CFI DIFC' Website may contain links to external websites and through the existence of these publicly available links, the Company does not endorse or take any responsibility regarding their privacy, practice or policies. This applies as well on any other information voluntarily provided by you.

1. Information, Collection and Use

CFI DIFC does not collect personal information when visiting its Website or through its other online services, unless these information are provided by upon registration. However, CFI DIFC does collect aggregated information.

Additionally, these information actively provided by individuals may be recorded by CFI DIFC when using the Company's registration form, such as:

- a) Browser used,
- b) Internet IP address,
- c) Tracking Cookies,
- e) Date, time and duration of online activity.

The above information is collected for statistical purpose and used to help diagnose problems with the server. These information are not used in any manner for revealing personal information except as described before.

All personal information provided to CFI DIFC through the Site is purely voluntary in nature. If you do not want your information to be collected, please do not submit such information to the Site. If you have already submitted personal information to the Company and wish to have them removed from the records, please contact CFI DIFC and send a request to info@cfidubai.com.

When contacting us, we may ask you for information such as: the name and the company's name (if applicable), the address, the date of birth, the home address, the telephone, business and mobile numbers, as well as any other identifying information which may be required by CFI DIFC occasionally. Please note that upon contacting CFI DIFC, you are not considered by the Company as anonymous anymore.

Information about your transactions with CFI DIFC are collected, including information about your use of the Company's Site, the dates and times you have accessed the Website, the version of the terms of use and Privacy Policy which you have accepted every time you log in and any other information freely provided, which CFI DIFC may choose to collect occasionally.

CFI DIFC may automatically receive and record information on its server logs from your browser, including your IP address, cookie information, and the page that has been requested.

CFI DIFC uses information for the following general purposes: fulfill clients' requests, improve the Company's products of services, for contest registrations and sweepstakes, for the submission of publications and/or advertisements, to provide information to third parties affiliated to CFI DIFC and to contact the clients. We will not provide your information to nonaffiliated third parties without your prior consent but we may refer and share your information with companies within the same group.

By entering personal information into the Site, you acknowledge that you are of legal investing age in the jurisdiction in which the access to the Site was made.

2. Information, Sharing and Disclosure

CFI DIFC is securing and encrypting the confidential information where appropriate. Information entered will not be used by the Company for any other purpose than the purposes being described on the Site and in this policy.

CFI DIFC does not rent, sell, or share personal information about its clients with other people or organizations except as provided herein, or under the following circumstances: We respond to orders, court orders, legal process, to establish or exercise the Company's legal rights or to defend against legal claims; We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of CFI DIFC' terms of use, or as otherwise required by the law. We will not provide your information to nonaffiliated third parties without your prior consent but we may refer and share your information with companies within the same group.

3. Cookies

CFI DIFC may use web beacons to access CFI DIFC cookies inside and outside the Company's network of websites and in connection with the Site's Services. The Company may set and access CFI DIFC cookies on your computer. Cookies are pieces of information that may track visitors' source, click source, search keywords, and many other information used to get to the Company's Website and user circulations to related web pages. Some web-based services require those cookies. Please note that we do not sell or distribute those confidential agreements to any other third party. Any information that the website may store in cookies, is used exclusively for internal purpose only. Information gathered may be shared with other entities within our group.

4. Changes to This Privacy Policy

CFI DIFC may update this Policy occasionally. The Company may provide its clients with notices, including those regarding changes to the agreement, by: e-mail, regular mail or postings on the Site.

5. Monitoring

CFI DIFC will have the right to monitor live information for the client if he/she is chatting with the Company using the live chatting system, which will detect if the client already exists within the CRM system.

6. Security

The CFI DIFC Website is relatively secured from several injections such as spams and many other illegal "Trojans" viruses that may result in any failures by using special encryption and special captcha prevention.

This being said, it is excluded that CFI DIFC can guarantee the security of all information and as such some residual risk still exists as it is the case while providing any information online. You consent to this risk by accessing our Site.
